Yes—U.S. citizens and permanent residents can travel to Cuba **legally** under the **General License for Support for the Cuban People**, one of the 12 authorized categories of travel established by the U.S. Treasury's Office of Foreign Assets Control (OFAC). Who Can Travel Under This License?

Anyone under U.S. jurisdiction who is **genuinely interested in supporting the Cuban people** can travel under this license. The intent of this license is to encourage authentic interactions with Cubans and promote civil society by:

- Patronizing **privately owned restaurants**, galleries, shops, and other small businesses
- Engaging with **independent Cuban artists, community projects, and entrepreneurs**
- Participating in **educational, cultural, and community-based exchanges**

While **general tourism** to Cuba remains prohibited for U.S. travelers, visiting under the **Support for the Cuban People** license is a fully legal pathway that allows for rich and purposeful travel experiences.

How Does It Work?

Unlike a traditional visa application, the General License process is **self-directed**—no need to submit paperwork for pre-approval. Instead, travelers must ensure their trip complies with OFAC guidelines and maintain supporting documentation for up to **five years**.

At **AC Journeys**, we provide everything you need for compliance, including:

- A **travel affidavit** designating your category of travel
- A **detailed itinerary** consistent with OFAC's full-time schedule requirement
- A **guide to current Cuba travel regulations**, including updates to the **Cuba Restricted List** (prohibited entities)
